Chuted Vehicles

Remember, Safety First!

We all need to re-educate ourselves when it comes to chuted work.

Scenario: Near fatal hit - the material slid from the front of the body to the back having enough force to break the securing points & forcing the tailgate open. Approximately 10 tonnes of material was discharged onto the road burying the wheel barrows.

Best Practice



To help prevent the chuted vehicle being condemned:

- Add to daily defect sheet
- Checked regularly or 6 weekly
- Haulier to Introduce chuted work training
- Driver to carry out onsite risk assessment to incl chutes use
- Check onsite for chute delivery guidance with customer

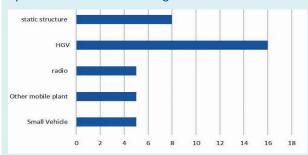
Incidents involving mobile plant

Please **DO NOT** raise any mileage queries for missing mileage payments, between the dates shown above.

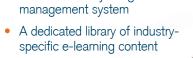
